# **Message from the Racial Justice Task Force**

Francine D. Spang-Willis read the following acknowledgement of Indigenous Peoples and Lands at the recent meeting of the Racial Justice Task Force Advisory Team and graciously agreed to share it with the Synod. The Advisory Team is a group of Native American leaders and leaders of color who advise and direct the Strategy Team's work.

### Indigenous Peoples and Land Acknowledgement

As you might be aware, this beautiful and sacred landscape has a layered history. Millions of Indigenous humans had existed on it and engaged with it for thousands of years before it became known as the United States. **Today** millions of Indigenous peoples are still connected to it, including **but not limited to** the following Indigenous nations and people in Montana:

- Assiniboine & Sioux
- Blackfeet
- · Chippewa & Cree
- · Confederated Tribes of the Salish, Kootenai & Pend d'Oreille
- Crow
- Gros Ventre
- · Little Shell Band of Chippewa Cree
- · Northern Cheyenne

We also **all** have a relationship and connection to the landscape as we engage with it for sustenance, spiritual, and recreational reasons. Like our Indigenous ancestors that came before us, we must also help to fulfill our stewardship responsibilities. It is our turn to take care of each other and the land, so future generations can exist on it and enjoy it as we do today.

We must also learn about the impacts of colonization, the processes of colonialism that are ongoing for Indigenous as well as non-Indigenous peoples, and the deep sacrifices made so we can enjoy the land. We must also work past the processes that harm the land and all living beings on it.

We can begin by simply acknowledging Indigenous peoples and their traditional homelands. This simple act of recognition has the potential to help with the reconciliation,

healing, and progression of all people. But we must not stop with an acknowledgment. We must also respect diverse ways of doing and being and include them in our current processes.
