## Rev. Brenda K. Smith

is Program Director for Faith Practices and Book of Faith in the Domestic Mission Unit of the Evangelical Lutheran Church in America-Churchwide Office in Chicago, Illinois. In this role she heads the Faith Practices Team, which is developing strategies to create a culture of discipleship in the ELCA. Rev. Smith and another staff member, Rev. Sara Vanderpan, coordinate the Book of Faith ministry of the ELCA; a ministry that has the



goal that individuals and congregations will be intentional about opening the Bible and having conversations about the transformative power of the word of God. She also convenes the ELCA's Renewal/Prayer/Revival Team that offers healing and prayer services; Lutheran revivals; and workshops on various topics for congregations and synods.

Prior to her current position Rev. Smith was pastor of New Hope Lutheran Church in Jamaica, New York for 13 years. Before answering God's call to ministry, she was a pediatric nurse and taught pediatric nursing at Capital University in Columbus, Ohio. She attended New York University where she received both her B.S. and M.A. in nursing. She received her Master of Divinity degree from Trinity Lutheran Seminary in Columbus, Ohio.

In her spare time Rev. Smith enjoys spending time with family and friends, watching movies, reading and listening to Motown classics, especially any songs by the Temptations.



## **Linda Bobbitt**

is a researcher and project manager for the Congregational Vitality Project for the ELCA. This project focuses on how congregations live into their relationships with God, one another and their neighbors. Linda works

with synods and congregations to learn about the factors that influence congregational vitality and what congregations, synods, and the wider church can do to strengthen it. The website she developed

(<u>congregationalvitalityproject.com</u>) provides summaries of research and hands-on resources to help congregations engage in fruitful conversations about how to be or become a more vital church.

Linda has published articles on how to measure congregational vitality in the Review of Religious Research (a peer reviewed journal) and regularly presents research at the annual meeting of the Religious Research Association. She also serves on the steering committee of the multi-faith Cooperative Congregational Studies Partnership. Linda has over 20 years of outcome measurement and program evaluation experience, and over 15 years as a lay leader (Congregational President and Synod Vice President) in the Lutheran church. She has a Master's of Arts in Congregational Mission and Leadership from Luther Seminary and a Master's of Science in Counseling Psychology from the University of Kansas.

## 2018 Montana Synod Secretary's Report

The Council of the Montana Synod met three times this past year; in June 2017 just prior to the Synod assembly, in September 2017 and in February 2018. The Synod Council is commissioned to conduct the business of the Synod between Synod Assemblies, as well as set the direction for the Synod. The Council conducted the following business:

- Transferred a tithe from the Synod House Campaign to the Mission Venture Capital Fund.
- Adopted changes to the 2018 budget.
- Elected Neal Wedum, Lisa Carlson, Dick Deschamps to the Executive Committee.
- Appointed the Executive Committee to serve as the Resolutions Committee for the 2017 Assembly.
- Accepted the proposed date of May 31-June 2 in Great Falls for the 2019 Assembly.
- Affirmed Bishop Crist's appointments of Pastor Amanda Liggett as synod secretary and Russ Plath to the synod council.
- Authorized the spending of up to \$2500 of disaster response funds to assist in fire relief.
- Adopted the recommended minimum salary guidelines.
- Changed the tithe on future contributions to the Capital Campaign to Montana Synod mission partner congregations (Freedom in Christ Prison Ministry, Our Saviour's Rocky Boy, and Spirit of Life) until the building is paid for.
- Nominated Pastor Amanda Liggett as secretary of the Montana Synod for election at the 2018 Synod Assembly.
- Transferred \$10,000 from our cash to the restricted account 02-341-05006 to fund Freedom in Christ for 2019.
- Determined that the 2018 synod assembly offering be used for relief support in Puerto Rico.
- Approved suggested amendments to the personnel handbook regarding family medical leave and to the sexual misconduct policy.
- Recommended the projected budget for 2019 to the Synod Assembly.
- Approved On Leave from Call Status: Deacon Brooke Ells, Pastor Robin Luckey, Pastor Maryann Morgenstern, Pastor Brenda Satrum, and Pastor Stacy Siebrasse.
- Approval of Retirement Roster Status: Pastor Joel Brosten, Pastor George Karres, and Pastor David Rommerein.
- Approved Disability Status for Pastor Len Shatkus.
- Approved New Synod Council Calls: Pastor Tim Spring, Pastor Peggy Paugh Leuzinger, Pastor Elizabeth Liggett, Pastor Patricia Harant, and Pastor Paul Balaban.
- Reviewed Synod Council Calls as of May 2017.
- Appointed: Pastor Linda Rose to the Candidacy Committee, Pastor Tanner Howard and Jan Martin to the Mission Table, Joan Schmidt to the Candidacy Committee, Pastor Jessie Obrecht as Hunger Coordinator, Pastor Elizabeth Liggett and Wayne Leininger to the Hetzel Foundation,
- Approved the dissolution of the Bridging Faith (Our Savior's, Laurel and Joliet, Joliet) and Upper Musselshell (Harlowton, Barber, Lennep) parish agreements.
- Approved the proposal that Montana Synod congregations may have seasonal members.
- Approved the release of Immanuel, Joplin.
- Rescinded Synod Council action SC.07.02.25 "Policy change that Bishop live in the city where Synod Office is located."
- Ecumenical Appointments: Risa Paul (PCUSA) to Trinity, Hot Springs and Ric Beals (PCUSA) to St. Paul's, Cut Bank
- Heard reports from Bishop Crist, Associate to the Bishop Jason Asselstine, Tech Advisor to the Synod: Colter McCarty, Synod Treasurer: Sue Ost, Director of NRIT: Jenny Kunka, CEO of St. John's Lutheran Ministries: David Trost, Synod Vice President Tom Gossack, LDR Director Dick Deschamps, Pastor Peggy Paugh Leuzinger, DEM, and welcomed several guests to Synod Council meetings.
- The council reviewed the Synod Benchmarks at each meeting.

I would like to thank the synod for the opportunity to serve as secretary this past year. It has been a privilege to serve with the dedicated men and women of the council, as well as to work with our talented Synod staff.

## **ELCA Fund for Leaders Montana Synod**

## 2018 Annual Report

Thank you to the people of the Montana Synod for making an investment in the future of the church through the ELCA Fund for Leaders. Our goal is to provide full-tuition support for every rostered ministry candidate at our ELCA seminaries. Together, we are making great progress toward that goal.

In the 2017-18 academic year, the ELCA Fund for Leaders provided scholarship assistance of more than \$2.1 million in support of 251 future pastors and deacons. Thank you for your role in ensuring that these future leaders will be freed from the burden of student debt so that they can go and serve as the church needs and the Holy Spirit leads.

## Your fund

Since its inception, the Montana Synod Fund for Leaders endowment has awarded scholarships of \$20,597.00 for seminary tuition, and the ELCA in total has awarded more than \$17.5 million. We are grateful that the Montana Synod Fund for Leaders scholarship endowment provided a total of \$4,500.00 in tuition support during the 2017-18 academic year for:

- Joshua Gomez \$500 Wartburg Theological Seminary
- Annela Rova \$4,000 Pacific Lutheran Theological Seminary

As of Dec. 31, 2017, the Montana Synod Fund for Leaders scholarship endowment had the following:

- a total market value of \$152,994.03;
- a total of \$0.00 in new gifts in 2017;
- a remaining balance in the income account of \$3,286.62; and
- \$6,200.00 available for scholarships in the 2018-19 academic year (represents amount after a 10 percent conservative cushion retained by Fund for Leaders to account for sudden market fluctuations).

## 2018 awards – what's new?

Beginning in 2018, the ELCA will use a new platform, **ELCA GrantMaker**, for awarding scholarships and grants. As in the past, we are looking forward to receiving the name(s) of the students your synod wishes to support this year through synodical Fund for Leaders scholarships. This year, synods will also direct their applicants of choice to ELCA GrantMaker, where they will submit their contact information to Fund for Leaders. Please read the **Guidelines for synod scholarship funds** document carefully for instructions on this year's scholarship award process.

Although Fund for Leaders awards are intended primarily to pay for tuition, books and fees, students who already receive full-tuition support through Fund for Leaders may also receive synodical scholarships to help with additional expenses. Note that scholarship funds used to cover costs beyond tuition, books and fees (such as room, board, insurance, etc.) will count as taxable income to students and should only be granted provided that there is a clear understanding between the synod and its donors about how the funds will be applied. Please work with seminary financial aid offices to make sure your students are aware of the tax implications of such scholarship awards.

We will notify synods by mid-April of our full-tuition award decisions for the coming year so that synods may plan accordingly. We encourage you to prayerfully discern which rising candidates would benefit most from the support you can offer. Synods should notify Fund for Leaders and students of their nominations no later than May 15, 2018, and nominated students must complete the Fund for Leaders Synod Scholarship application in ELCA GrantMaker by May 31, 2018. Applications received after this date run the risk of not being awarded in the fall semester.

Finally, we ask the Montana Synod, its congregations, and its members for continued support of Fund for Leaders as a meaningful way to make an investment in the future of this church and its leadership. A gift to Fund for Leaders is a wonderful way to celebrate a pastor's ordination or a deacon's consecration, the installation or retirement of a new pastor or deacon, or the anniversary of a congregation.

Again, thank you to the people of Montana Synod for your generous support, and thanks be to God for you!

**The Mission Investment Fund (MIF)** is the lending ministry of the ELCA. MIF makes low-interest loans to ELCA congregations and ELCA-related ministries for building and renovation projects. With MIF loans, congregations and ministries can purchase property, construct new buildings, and expand or renovate existing facilities.

MIF loans expand the capacity for ministry. MIF loans help create expanded worship spaces, updated space for education and youth ministry, new kitchens for community meals and soup kitchens, affordable housing units for the community and much more.

At year-end 2017, MIF had 888 loans outstanding, totaling \$539.1 million.

To fund these loans, MIF offers a portfolio of investments for congregations, their members, synods and ELCA-related ministries to purchase. At year-end 2017, MIF investments totaled \$506 million.

MIF is a financially strong and stable organization, with a record of steady, controlled growth. With total assets of \$715.7 million and net assets of \$203.9 million at year-end 2017, MIF maintains a capital ratio of 28.5 percent—positioning MIF in the top tier of well-capitalized church extension funds. 

## A MESSAGE FROM

ALLAN BELTON, ACTING PRESIDENT

Pacific Lutheran University's priority is to continue to focus on our students — their learning and their success. We realize this priority when we increase scholarship opportunities, when we invest in academic programs that match 21st-century needs, or when we develop new resources that support students from admission to graduation at PLU. This year, several projects and initiatives undertaken stand out as especially noteworthy for the positive impact they've had and will continue to have on this institution and its students.

We are hard at work on a **new student success center** (located in the Mortvedt Library) that will provide our students with individualized academic and personal support and resources through a collaborative, student-centered approach. Services offered will include academic advising, tutoring, supplemental course instruction, registration transactions, coaching and other specific support services for all students, with particular attention to first-generation, lowincome, first-year, veteran and transfer students.

Another way we've invested in student success is by creating a one-stop financial shop by restructuring Financial Aid and Student Services. This newly created office provides students with counseling and processing for financial aid, billing and payments, VA benefits, financial literacy and student loan repayment. This effort has been an example of how PLU can innovate on behalf of our students.

Service is a fundamental part of our university's mission, and as Lutes we've always tried to answer the needs of our communities. The PLU School of Nursing recently received a \$1.4 million ANEW grant from the federal Health Resources and Services Administration (HRSA). The grant is targeted at expanding curriculum, doubling nurse practitioner student numbers and sending those students

into medically underserved areas around the state. With support from the Andrew W. Mellon Foundation, faculty continue to explore important curricular revisions that create strong learning communities, build intentional connections across the curriculum, and foster our Integrative Learning Objectives. Two Mellon Foundation grants — an initial grant for \$100,000, and a second grant awarded this summer for \$500,000 — provide funding for building faculty capacity across a range of curricular initiatives.


Supporting social justice is intrinsic to the core tenets of Lutheran higher education. The Undocumented Student Task Force was formed in fall of 2016 with the goal of purposefully reviewing and addressing the unique barriers to success that undocumented students experience at PLU. The Task Force initiated a crowdfunding campaign and raised over \$30,000 — nearly four times the group's original goal of \$8,000. The funds have assisted individual undocumented students in persisting at PLU and also assisted in setting up a textbook lending library.

Beginning in January 2018, Dr. Jennifer Smith was installed as PLU's first **Dean for Inclusive Excellence**. In this role, Dr. Smith provides necessary attention to diversity and inclusion issues directly affecting student success, while simultaneously investing in professional development and support for faculty in areas ranging from recruitment and hiring to curriculum development.

This past year also included meeting

our challenges head on. Twenty members of the Faculty Joint Committee took on the challenge of realigning our educational program to meet the needs of our student body. The committee, comprised of faculty representatives from every academic division and school, spent seven months reviewing enrollment data, soliciting narratives from academic leaders to understand their enrollment trends, and analyzing the higher-ed landscape to develop its recommendations. The faculty took ownership of our educational mission and made the difficult choice to reduce their own ranks. In time of need, they didn't bury their heads in the sand, they stood up to the challenge. PLU will be a stronger university as a result of that work.

In the midst of challenges and opportunities, the power of our greatest resource — our people — and the impact they will continue to have for generations to come has never been more apparent. We are the heirs of an unfinished Reformation, a reform that is ongoing and that must always be open to new voices and fresh perspectives. At PLU, we are inspired by this challenge. We are convinced that our future will be as transformational as our past. In that conviction, we will continue to celebrate our successes and confront our challenges with a reforming spirit and unwavering resilience. In a world that faces growing uncertainty and societal divides, the world needs more Lutes now more than ever.

There are two significant pieces of data that shine a light on the changing church in which we all find ourselves.

- Within the next couple of years, between the rate of retirements in the ELCA and the trends in seminary enrollment, there will be 1,000 congregations who could otherwise afford a full-time pastor who will not have one.
- The ELCA seminary system does not have the number of students needed to respond to those vacancies.

At the same time, we see a world that needs more than ever the honesty, integrity and unconditional welcome embodied in the gospel message. We see ministry erupting in the most surprising places and forms. Our students are so clearly called to serve in the name of the gospel, inspiring us all to do our very best.

From within our circle of influence, Luther Seminary has been addressing these realities and leveraging these assets. Our mission is to educate leaders for Christian communities, called and sent by the Holy Spirit, to witness to salvation in Jesus Christ, and to serve in God's world. We need to be innovating in a rapidly changing world

Over the last year, we have embraced the hallmarks of adaptive change: adjusting to and understanding the rapid change

occurring in the church and authentically undertaking the gradual but meaningful process of change.

Our staff and faculty spent the latter half of the year imagining a new future for Luther Seminary, a future that will be more suited to the context in which we and our students minister. In addition,

- our budget was reduced by \$1 million so we could focus our core operations;
- the proceeds from the land sale are earmarked for strategic reinvestment, not to fund operations; and
- 112 new leaders were launched to lead across the globe, 43 percent of them without any educational debt.

We are eager to engage in new kinds of listening and learning to pay attention to where God's Holy Spirit is stirring. The results of this last fiscal year have positioned us well to invest in new arenas and to experiment with new pathways of leadership formation, to deeply engage and listen to places where innovation is happening.

Thank you for your prayers. Thank you for mentoring people for leadership in the church and inviting us to accompany them in their preparation and discernment. Thank you for your financial support which makes it possible for us to engage in this adaptive work.

## **New Curriculum for a New Day**

We are excited to share the news that our faculty have collaborated to develop a new curriculum which will be implemented in the fall of 2018. The new curriculum can be completed in three years instead of four, including internship. This addresses concerns regarding student debt by saving a year of residential costs. The new curriculum is shaped by four orienting perspectives that emphasizes cultivating spiritual practices and skills for building community, putting Christian beliefs and practices into collaborative engagement with other religious traditions and secular disciplines, and faithful social transformation grounded in the good news of Jesus Christ. The curriculum maintains the solid theological, biblical and ministerial formation that is the hallmark of Lutheran theological education and aims to prepare pastors for both traditional and emerging forms of Christian communities that are centered in the gospel of Jesus Christ, social justice, and ecological well-being. The new curriculum will take advantage of our central location in Downtown Berkeley, California by providing a growing number and expanding opportunities for community engagement.








## Synod Spotlight: Annela Rova, M.Div.'21

## Annual Report, May 2018

**Student residents and staff**: We currently have 11 students living in the Ark and Emmaus House and about 20 more who are active in some way with us. This year we had about 15 students and young adults working on staff or on internships related to different aspects of our ministry. We also connect with and relate to 6-8 UM departments and have about 65 faculty and staff contacts.

**Program:** A good try: last winter and spring we started a new young adult group called **Confluence** that met weekly, with about 4-6 key leaders to make it go. We had a good group going with momentum, but suffered losses to our leadership. By the fall all the core leaders had either moved or went back to school and were unable to continue. Thus, Confluence is on hold for now. However the desire and interest is still there if we can build the leadership to make it go.

This fall we moved into a Wednesday night group called **Salt and Light**, and a Sunday night **dinner and discussion** group. Both groups were able to hold average attendance of 8-12 with great conversations, devotions, and connections.

This spring we came back to trying a Worship format on Wednesday nights. This was sparsely attended but held with a core group. This has shifted into Wednesday night gatherings around our outdoor fire ring with storytelling and music with a much stronger response. We continue to adapt and listen to the needs and desires of the group.

**Volunteerism and serving others**: Through our Friends in Need we have students helping with Family Promise, Habitat for Humanity, food drives, and other projects about once per month.

**Outreach Worship**: We also have an outreach worship team of 6-8 students who leads worship and gives the message in various churches around Western Montana once per month.

Retreats and Trips: This past year we had a successful winter retreat at Georgetown Lake and a sailing retreat on Flathead Lake.

**Faith and Climate Action**: Emmaus is the fiscal holder of this group and continues to support interns to help it run. This group is offering quarterly educational events, and in April hosted "The Time is Now" conference in Missoula with about 70 people attending various events.

**SALAM**: Emmaus is also the fiscal holder for this Muslim ally group and also sponsors two interns who have provided leadership along with a strong steering committee. This group offers larger community educational events, Celebrate Islam Week in the spring, and smaller educational and social events as desired and needed.

**Anti-Racism Work**: Pastor Lund is an active member of the Missoula MLK Day planning team and is also on a team of community leaders building an Anti-racism Coalition in Missoula that is building active leadership, goals, and networks.

**MIC/Family Promise and the YWCA family housing project:** Pastor Lund continues to represent MIC and Family Promise at the table with the YWCA to help vision and negotiate the larger family housing project that is coming together. This will be an exciting partnership that will roll out over the next few years as it comes into fruition.

Intro to Honors Course: Pastor Lund continues to teach the freshmen fall Honors course called "Finding Your Path" with about 18 students each fall.

**Buildings and Grounds:** We have recently made our 8<sup>th</sup> payment out of 10 to the Glacier Presbytery for the buyout of the Ark (10-year buyout). Currently we are considering a new firepit and bicycle shed this summer.

## May 2018 Report

**Mission Statement**: As a people of faith, we empower Wyoming's faith communities to promote social and environmental justice through prayer, discernment, respectful dialogue, leadership, advocacy, service and study.

Mantra: Fear not. Be bold. Build Bridges. Do justice.

## Activities in 2018:

**Becoming interfaith.** At the October 2017 Annual Board Conference, the Board voted to become interfaith, and to change our name from Wyoming Association of Churches to Wyoming Interfaith Network (WIN).

**New Board Chair.** Rabbi Larry Moldo, of Mt. Sinai Synagogue in Cheyenne, was elected as the new Chair of the Board of Directors at the October 2017 meeting. Previous Chair, Carl Carmichael, remains on Executive Committee and facilitated a smooth transition. Rabbi Moldo received his Ordination in 2005 from the Academy for Jewish Religion, New York. While in Seminary he participated in an interfaith Colleagues in Dialogue Seminar hosted by Sacred Heart University. He has been involved in interfaith endeavors ever since.

**New Executive Director**. In January of 2018, WIN hired a new Executive Director, Susie Markus. Susie holds a bachelor's Degree in Social Work, a Master's in Counselor Education and a PhD in Educational Leadership. The focus of her work has always been on fostering relationships and community connectedness to improve health, wellness and equity, with and on behalf of marginalized people. Susie specializes in storytelling for social justice and educating about historical roots of intersecting disparities to promote peaceful, supportive, inclusive, socially just spaces for all, where we grow, live, learn, work, play and pray.

**Children, Youth and Families Focus.** The focus of work for WIN this year is children, youth and family health and well-being. We are exploring grant opportunities and partnering with several organizations and churches to determine specific projects and programs to further this focus.

**Legislative Session 2018.** Chelsie Lee continued as WIN's lobbyist in the 2018 Legislative Session. She was especially instrumental in lobbying against Senate File 74, a bill that would have made new criminal classifications for those damaging or slowing down critical infrastructure like oil and gas facilities or pipelines. Under such a law, WIN could have been subjected to a fine of \$1 million for encouraging dissent and protest against an infrastructure that our membership believed to be potentially causing more harm than good. This bill passed, and Governor Mead vetoed the bill.

Fostering a culture of connectedness and interfaith humility: At the WIN Board Retreat in Lander, WY in August 2018, Susie Markus will facilitate a PhotoVoice storytelling project in which members of the Board will take photos and provide related narratives to depict their faith traditions to tell individual stories and one collective story of what it means to be an interfaith network. This will affirm that our network of peoples of faith, our common humanity, and the richness of our varied religious traditions are deeper than our divisions. The PhotoVoice stories will be featured on WIN's new website and shared widely to strengthen our network to work together for the good of the people and for reconciliation among all races, conditions and ideologies.

## **Montana Synod Candidacy Committee**

The Montana Synod Candidacy Committee is part of the ELCA ministry that seeks to identify, nurture, train, and approve leaders for the public ministries of the church. Candidacy invites an active participation of congregations, Candidacy committees, seminaries, and the ELCA's Congregational and Synodical Mission unit, to work together with individuals who are discerning whether their vocation in life includes service in the church's "rostered ministries."

The ELCA's public ministries are now ordered in two **rosters**. Most people are familiar with the ministry of those who are ordained as **Ministers of Word and Sacrament**. Their preparation is ordinarily as residential and/or distributed-learning Master of Divinity students at a seminary, or through TEEM (Theological Education for Emerging Ministries), an ELCA initiative using seminaries and synods to prepare leaders for service in special locations/situations of Word and Sacrament worshiping communities. In addition, there are also **Ministers of Word and Service**, a category that includes lay rosters previously known as Associates in Ministry, Diaconal Ministers, and Deaconnesses. Their preparation may include seminary training or another masters degree program, video course work, and special work in their areas of specialization.

(Besides the ministries towards which Candidacy is directed, the Montana Synod also has a separate program for preparing and recognizing Lay Pastoral Associates [LPA] for various kinds of ministerial service within the Synod, sometimes as Synodically Authorized Ministers [SAM]. Some other synods have comparable programs.)

As it works with those who are discerning and preparing for church vocations, the Montana Synod Candidacy Committee, on behalf of the whole church, makes three important decisions along the way: *Entrance* recognizes promise for ministerial leadership and formally brings a candidate into the whole process. *Endorsement* acknowledges that the candidate is ready for internship or field work within the particular arena of ministry for which she or he is preparing. *Approval* indicates to the whole church that the candidate is now ready to be called into its public leadership.

Members of the Candidacy Committee include Peter Metcalf (Missoula), John Mundinger (Helena), Amanda Nelson (Missoula), Pastor Linda Rose (Billings), Joan Schmidt (Great Falls), Pastor Kim Wilker (Red Lodge), John Mundinger (Helena), Bishop Jessica Crist (ex officio), Rev. Mark Nelson (advisory, ELCA deployed staff), Rev. Dr. Kathryn Schifferdecker (faculty advisor from Luther Seminary), and Rev. Bob Quam (Synod staff representative, who functions also as Chair). Committee members not serving in ex officio or advisory capacities are appointed by the Montana Synod Council to four-year terms which may be renewed once.

## Report from the Director for Evangelical Mission in the Montana Synod

As the former secretary of the Montana Synod, I was a part of the conversations to craft the Benchmarks for the Montana Synod. From the first benchmark, to "meet the future boldly", the second, to "serve the world, especially the poor and those in need," the third, to "deepen faith and witness" and even the fourth, to "promote unity", all the benchmarks propel us to the final bench-mark, which is our focus for our Synod Assembly this year. As we gather for this Synod Assembly under the fifth Benchmark: "strengthen congregations", I believe that my call as the Director for Evangelical Mission is to strengthen and support congregations to be faithful to the gospel, and to be faithful to the ministry entrusted to each congregation and ministry. Congregations are seeking to be places of vitality and life and I am humbled to be able to walk alongside these congregations.

I began to serve as the Director for Evangelical Mission in the Montana Synod last September. Although each Synod of the ELCA functions in it's own unique way, the ELCA churchwide organization has called me and the other DEMs to serve as ELCA employees to be deployed in our own particular Synod to be about the work of strengthening congregations. Through the work of the DEMs, the churchwide partnership is visible as together we work to strengthen congregations.

In the course of the last months, I have worked to develop and deepen relationships with clergy and congregations in order to hear and support them in their efforts to strengthen their own congregations. Through the process of several Comprehensive Ministry reviews, the review teams and I have listened carefully to leaders describe what they experience and hope for within their own congregation. I have stated that I am committed to walk with those congregations and pastors in order to strengthen them to reach out in their community and to focus energy on being more effective as the people of God for the sake of their community.

As a resource to clergy and congregations I have worked to empower congregations to be more effective and faithful in their stewardship practices. I also have worked to lift up the ministry of the whole Montana Synod and ELCA in order to remind people of the work in which we share together. As a sign of that partnership, during the Friday evening worship during our Synod Assembly, voting members will receive a copy of their congregation's "Statement of Intent" and will join in a processional offering of those statements as a symbol for all of the offerings received in congregations and which are then passed on to the Montana Synod that are part of how we are church together for the sake of the world.

I also serve as the liaison to the ministries in the Synod, which receive Mission Support money from the Synod and from the ELCA. Currently, these three ministries receive money from the ELCA, the Montana Synod and from congregations and individuals. ## KOGUDUS RENEWAL MINISTRY (2017 Annual Report to the Synod)

The Board of Directors of K.R.M. and I thank the Montana Synod and all who have supported this retreat ministry in 2017 and previous years. As a partner in ministry K.R.M. continues to promote and equip lay leadership in the Church and community. This partnership began in 1976 under the leadership of Rev. Olaf Magis who began Kogudus retreats in in 1969 while he was a pastor of First Lutheran Church in Glasgow, Montana. The Estonian word, Kogudus, means "Christian fellowship". Olaf chose that word to convey the **message of Christ, fellowship in Christ,** and **service for Christ.** Kogudus retreats have been held throughout the U.S. and in other countries throughout the world. In recent years, however, there are three states that continue to offer retreats: Montana, North Dakota, and Illinois.

The original retreat called "Faith and Life" is a study of the Apostles' Creed and the New Testament Greek words for different kinds of servants. It encourages those who attend to discover their God-given gifts and consider how the Holy Spirit calls them to put those gifts to use for the common good of Christ's Church and the world. Another retreat, "Lament and Laughter", was introduced in 2011. In connects human losses to the cross and joys to the resurrection. Dying and rising in Christ (daily baptism) is experienced at this retreat and encouraged as a daily practice.

"Contrast Community" was introduced in 2014. It is a retreat inspired by Dr. James L. Bailey's book by that name and is a study of the Sermon on the Mount. This retreat has been held at both the state women's and men's prisons in Montana and the three state prisons in North Dakota. It was also offered at Our Saviour's Lutheran Church on the Rocky Boy's reservation in Montana by the Bear Paw Cluster pastors and LPAs. Here is a comment from one participant: "I want you to know what I felt in that place (Montana State Prison) for three days: Peace, Contentment, Joy, THE SENSE OF GOD'S PRESENCE."

There were a total of 11 retreats held in 2017. Montana and North Dakota both hosted 3 "Contrast Community" retreats. North Dakota hosted 2 "Lament and Laughter" events. Illinois hosted 3 retreats: 2 "Faith and Life" and 1 "Covenantal Living". All of the Illinois retreats were held at Camp Griesheim. A total of 200 people attended K.R.M.'s retreats in 2017.

For the first time a "Pilgrims in Recovery" retreat will be offered at both the state prisons in Montana and at Rocky Boy in 2018. This retreat was held once at Flathead Lutheran Bible Camp in 2003 for those recovering from addiction and/or co-addiction. It connects the 12 Steps of A.A. and other recovery programs with their Biblical basis in order to offer spiritual support and guidance to Christians and others who seek serenity.

Kogudus Renewal Ministry is grateful for the support and cooperation of the state prisons in Montana and North Dakota as well as the hospitality of Rev. Rob Nedbalek at Freedom in Christ ministry. We also thank Chaplain Charles Bott for graciously accommodating K.R.M. retreats at Montana Women's Prison.

## LPA Report

In 1997 the Montana Synod established the Lay Pastoral Associate (LPA) program to train and equip qualified laypersons for a congregational-based ministry of preaching, administration of the sacraments, worship leadership, and where appropriate, leadership for Bible study, catechetical instruction, visitation and spiritual growth. Once completed, Lay Pastoral Associates are licensed by the Bishop to serve our synod as interims, pulpit supply, and in other capacities.

Lay Pastoral Associate trainees follow a two-year curriculum that includes intensive coursework in Old and New Testament, Church History, Lutheran Theology, Preaching, Worship, Prayer and Spirituality, and Pastoral Care. LPA candidates are mentored by an ordained ELCA clergy person in their own or a nearby congregation.

2017-2018 has been a banner year for the LPA program. Not only do we have one of the largest classes on record for the program based out of Great Falls, we added a class in the eastern part of the state to accommodate the need.

Our LPA West class meets at the Ursuline Centre in Great Falls in October and in April each year. The majority of this class will finish this spring and be recognized at the Synod Assembly in June making way for a new class of LPAs to begin study in October of 2018. Our LPA East class meets at Zion Lutheran Church in Glendive, Mont. They have just finished their first year.

Last fall our largest class began with a course on prayer with Pr. Dan Heskett and this spring they learned about worship and worship leadership from Pr. Sandy Van Zyl. They have yet to engage in a Preaching course with Prs. Lindean Barnett Christenson and Steven Loy and training in Pastoral Care with Pr. Karl Guhn. With their mentors they are expected to be engaged in other activities like teaching a Bible Study or confirmation class, pastoral care and nursing home visits, and monthly times for checkin and conversation.

If your congregation is interested in having a member train to become an LPA, the next class cycle will begin in fall of 2018 in Great Falls. Please contact the Synod office for more information. Candidates need to be recommended by their Pastor.

And remember, if your congregation needs a supply preacher you can go to the Synod website and go to <u>resources>pulpit supply</u> and access the list of Lay Pastoral Associates who are available for pulpit supply.

Thank you to our course instructors Prs. Dan Heskett, Sandy Van Zyl, Christine Hollar-Dinsmore, Julie Long, Steven Loy, and Karl Guhn, for your valuable time and expertise. Also, thanks to Colter McCarty from the Synod office and Pastor Katie Emory for your help in making things run smoothly. They are responsible for keeping track of the progress of each LPA student and organizing the retreats. Their time and talent allow the program run smoothly.

## **Lutheran Disaster Response**

The Montana Synod is an affiliate organization of Lutheran Disaster Response (LDR). Lutheran Disaster Response strives to help the church continue to be church in the midst of disaster — following Christ's call to bring hope and healing to our neighbor in need. Some key areas of work include:

- Providing emotional and spiritual care for people who have been affected by a disaster and for leaders who respond to a disaster
- Coordinating volunteers through our local affiliates
- Assisting refugees in a holistic way by meeting the varied needs of the community
- Promoting disaster risk-reduction by helping communities build their assets thereby reducing the effects of likely disasters
- Providing long-term recovery efforts by addressing the unmet needs months or even years after a disaster strikes

Montana Synod concentrates on building resilient communities by helping families and churches work toward reducing their risks in disaster and to prepare for the disaster event which will inevitably occur. Resources are provided on the synod website.

Efforts have begun to work ecumenically to provide spiritual care for individuals affected by disaster. The synod emphasis will be to provide training to ordained and lay church leaders, who can then deploy to communities affected by disaster.

In March 2018 the Montana Synod through generous donations of Montana Lutheran congregations and members, as well as several synods across the United States, was able to provide in excess of \$16,000 to provide food on the Northern Cheyenne Indian Reservation. The shortage of food happened as a result of a winter weather and snow event.

There are always unmet needs in any disaster, as such was the case on the Northern Cheyenne Reservation this winter. We are now in the middle of flood season, with people affected. There is the potential for another vigorous fire season as many parts of the state are dry. Congregations and individuals are encouraged to give to the Synod Disaster Fund so that we are in a position to help out when the need arises. Thank you.

We had Pastor Al Erickson give a workshop on Human Trafficking and has since offered to come back to Montana or Northern Wyoming to put on more workshops. We also had Lois Olmstead as our Main Speaker. We will be in Townsend for our Fall Gathering.

## **Montana Synod Youth Report**

Over the past year focus on the youth of the Synod has manifested itself in two areas: The Montana Youth Weekend in April of 2018 and preparation for the ELCA Youth Gathering June 27-July 1, 2018.

## 2018 Montana Synod Youth Weekend

**YOU** are the Light of the world. ... "This means that without **YOU...** the world is a darker place." This was the theme of the 2018 Montana Synod youth weekend in Helena, MT. In April more than 30 youth and adults gathered for Service, worship, fellowship and education.

As part of this weekend, we were send out to the community for service to the Intermountain Children's Home to organize their donation center, Family Promise to rip out carpet and clean and rake around their building, and to the Helena Food Share to organize their pantry. It was great hands-on time of service and interaction between the youth and the leaders of these service organizations.

We were also able to engage with Pastor Jessie Obrecht, the Montana Synod World Hunger Coordinator, about issues related to world hunger and the impact we can make for the sake of the world. We met in small groups and created skits that helped to illustrate the needs facing our communities, and how we can address those needs.

We also took time to worship and sing songs, play pew battleship, sardines and who's your neighbor, eat homemade soup, dance and hangout together. ## **ELCA Youth Gathering Preparation.**

In June of 2018 270 youth and leaders from 25 different congregations in the Montana Synod will be traveling to Houston, Texas to Join more than 30,000 other Lutherans for the ELCA youth Gathering. The theme for the Gathering is "This Changes Everything" and focuses on the ways that God's Grace changes us and moves us to action for the sake of the world.

In January Pastor Jason Asselstine attended a training in Houston to be the Synod Coordinator of the Gathering. Following this training he traveled the Synod sharing information with youth and youth leaders about the gathering and recruiting congregations to attend.

The Synod is also organizing transportation to Houston via Bus. 70 youth and their leaders will be traveling on the Synod Bus and will be staying in Churches along the way. We will leave from Billings on June 24<sup>th</sup> and stop along the way to have fun at Six Flags over Texas.

While at the Gathering we will take a day to accompany the people of Houston and hear their story. We will walk alongside them and serve in a variety of ways. On our Synod Day, all 270 of us from Montana And Northern Wyoming, will gather together to get to know each other better and worship together with our Bishop. ## ST. JOHN'S LUTHERAN MINISTRIES ANNUAL REPORT

## ABIDING AND ADAPTING

For 54 years, St. John's has provided an array of human services that span the arc of life from beginning to end, while abiding in a mission to provide living opportunities within nurturing environments of hope, dignity and love. Amidst rapidly changing resident and healthcare needs among seniors, combined with diminishing traditional sources of revenue, St. John's is in process of intentional discernment, planning and repositioning in order to adapt, serve and sustain organizational well-being.

## PEOPLE SERVED

In 2017, St. John's Lutheran Ministries provided:

- 1,452 seniors with housing and life wellness experiences.
- 90 children received daily care within the Billings on-campus Center for Generations.
- 191 students received formal internship experience or scholarship support, including a pastoral intern.
- 420 people received outpatient occupational, physical or speech therapy.
- **375** people received inpatient rehabilitative care.
- 110 long-term care residents received a variety of rehabilitative and wellness services.



This joint venture of St. John's and St. Vincent Healthcare is now into its second successful year of providing premier quality care to senior residents at location in the Billings Heights. At year-end 2017, independent living apartments were 88% occupied. Assisted living and memory care resident populations are steadily growing. Residency inquiry is gladly welcome.



## HOME HEALTH AND HOSPICE

In 2017, Senior Independence of Montana, a joint venture between St. John's, the Billings Clinic and Big Sky Senior Services, provided home health care to 400 patients and hospice care to 92 patients in Yellowstone County. Inquiries are welcome as these valued services continue to expand.



Lutheran Social Services (LSS) and St. John's Lutheran Ministries have remained united in mission since 2002. In 2017, staff across Montana

counseled 65 individuals dealing with an unplanned pregnancy, inclusive of birthparents and related family members. Seven agency adoption placements were completed. Six eligible families await placement with a child and seven more are in the process of becoming eligible. Thirteen birthparents and adoptees received assistance with search and reunion, and two reunions were orchestrated. For the twelfth consecutive year, LSS was awarded a Dave Thomas Foundation Grant to help match children in state foster care with forever families. Our Wendy's Wonderful Kids recruiter, Diana Tolstedt, continues to work with children, families and foster children placement into permanent homes. During Adoption Awareness month U.S. Senator, Steve Daines, honored Diana for her faithful work in guiding Montanans through all aspects of the adoption process. LSS is in process of expanding its counseling and consultative services. In 2017, LSS provided 236 hours of mental health counseling and consultation, including services to Lutheran pastors of the Montana Synod. New staff additions include Trudi Paulson, LCSW, as Director of Family Services and Janet Ross, SWLC, as Birthparent/ Adoption Counselor and Mental Health Counselor.

## PHILANTHROPY -

St. John's and Lutheran Social Services are grateful for generous donors. Our endowed funds currently total \$5 million, providing enough income to meet 10% of charity care for residents in need. Program fees, deferred maintenance and Seeds of Kindness annual fund gifts from staff and friends of St. John's add to providing for charity care needs. In 2018, the St. John's Foundation will launch an Endowment Campaign to increase financial capacity to sustain services and improve quality of care at a time when traditional sources of funding are diminishing.

We will be able to articulate how everything that we do, everything that we advocate, everything that we commit time and money to will serve the world, remembering that the Gospel of John tells us that God so loved the world as to give Jesus, for the whole world. Through direct action, advocacy and cooperative work, we will minister to the poor, the poor in spirit, the forgotten and neglected. Realizing that this mission field is limitless, we will encourage coalitions, cooperation and establishment of meaningful priorities.

## 3. Deepen faith and witness.

"All authority in heaven and on earth has been given to me. Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age." (Matt 28:18-20)

We remember that Jesus called us to go and make disciples of all nations. We will support and encourage congregations to remain faithful in worship, Word and Sacrament. We will support congregations as they encourage their members to grow in faith and to broaden their witness in their communities and beyond.

## 4. Promote unity.

If then there is any encouragement in Christ, any consolation from love, any sharing in the Spirit, any compassion and sympathy, make my joy complete: be of the same mind, having the same love, being in full accord and of one mind. Do nothing from selfish ambition or conceit, but in humility regard others as better than yourselves. Let each of you look not to your own interests, but to the interests of others. Let the same mind be in you that was in Christ Jesus (Phil 2:1-5)

We remember Paul's image of the body of Christ. We will maintain a clear sense of who we are and whose we are. We will celebrate our diversity within the unity that is ours in Christ. We will give thanks for our many gifts of the Spirit as we explore our different responsibilities within the body.

## 5. Support congregations.

For you were called to freedom, brothers and sisters; only do not use your freedom as an opportunity for self-indulgence, but through love become slaves to one another (Gal 5:13)

We are a resource to congregations and pastors. The Synod leadership, staff and volunteer, will provide support to congregations to empower them to live out their calling as centers of mission. We will encourage and support the development of networks among clergy, lay leaders and congregations.
