## Generous Givers

Who has inspired you by their generosity? In a world that perceives scarcity, who has been an example to you of someone who “sees” abundance and shares of their abundance with others? As recipients of the grace of God, a generous response is care and concern for others. Generosity is a spiritual practice/a habit of the heart. What is your practice of giving/serving? ## Supporting Ministry

- Ask for the generous support of members and participants/supporters.
- Thank the supporters for their gifts of all sizes.
- Tell of the impact of the ministry in the community/ congregation or world.
- Clarify and share the mission of the ministry — the purpose of why you do what you do.
